MINUTES OF MUNICIPAL UTILITIES BOARD MEETING

MONDAY, JUNE 28^{TH} , 2021

The Municipal Utilities Board convened in regular session at the Watertown Municipal Utilities Board Room 901 Fourth Avenue SW Watertown SD on Monday, June 28th, 2021 at 12:00 p.m. with President Lisa Carrico presiding.

Board members present: Lisa Carrico, Chris Carter, Mike Luken, Dan Brenden and Rich Thomas. ITEM 7546

Motion by Luken with second by Carter to approve the agenda. Motion carried.

ITEM 7547

Motion by Carter with second by Thomas to approve minutes of Regular Session meeting on May 27, 2021. Motion carried.

ITEM 7548

Public Comment: Glen Vilhauer addressed the Board by introducing the new City Manager Amanda Mack.

ITEM 7549

Motion by Luken second by Carter to authorize General Manager to sign a Professional Services Agreement with CEG for the Ethanol Plant feeder addition. Motion carried.

ITEM 7550

This being the time and place set for consideration of bids, the following were presented. Bids for the Regulators and Meters for the Gas Department, Fire Suppression System for Uptown Substation for Electric Department. These bids were opened Thursday, June 24th, 2021, at 1:30 PM by the Watertown Municipal Utilities Staff as authorized by the Board.

Gas Meters: One bid was received and upon review and recommendation by Magstadt, motion by Thomas with second by Carter to award bid to low valid bidder KGM, Tonganoxie, KS for \$36,361.56. Motion carried.

Gas Regulators: One bid was received and upon review and recommendation by Magstadt, Motion by Luken with second by Carter to award bid to low valid bidder Nelson Technologies, Eden Prairie, MN for \$21,038.00. Motion carried.

Fire Suppression System: Two bids were received and upon review and recommendation by Magstadt, Motion by Luken with second by Brenden to award bid to low valid bidder Nardini Fire Equipment, Fargo, ND for \$51,282.00. Motion carried.

ITEM 7551

Open:

- a) Lehner presented the two-sided bill stuffer. Cookin' on Kampeska and preventing Storm Water Pollution.
- b) Lehner extended an invite to the Board for the MRES Municipal Power Leadership Academy taking place September 15-16 in Sioux Falls, SD.
- c) Lehner gave an update of the MECA Board Meeting he attended in Yankton, SD. The first day of the meeting started off with a tour of the Gavin's Point Dam and a Fish Hatchery. The main discussion in the second day of meetings was how to combat the Zebra Mussel problem in Gavin's Point Dam's water system. A UV system has been used to kill larva and make adult mussels sterile. They also talked about drought. This was the first MECA meeting held in person since COVID.
- d) The Retirement of Jeff Deville on June 30, 2021. Jeff worked over 33 years for the Watertown Municipal Utilities.

ITEM 7552

Old Business: The Watertown Municipal Utilities was not selected to receive the Cybersecurity Audit grant from MRES. Lehner mentioned that we should have future discussion on having our own audit because of the rapid cybersecurity concerns everyone has been having. This would help us see our vulnerabilities and give us a short- and long-range plan for creating safe practices.

ITEM 7553

Magstadt presented the Report on Operations and Projects: He started out by showing pictures of the June 11th storm. The crews had to replace a broken pole. He also showed a picture of a downed tree that barely missed our electrical lines. Fortunately, it had no effect on our system. Electric, total of 30 electrical unscheduled outages for 2021. Gas, installed about 3,500' of 2" plastic gas pipe at several different subdivisions, Completed Lake Kampeska leak survey, relocated a 4-inch service at the high school. Water, completed about 25 new taps, relocated a fire hydrant. Engineering Tech, Staking and Locating, Locate & detail fiber to Airport Terminal (Geldner Underground) 2.5 miles, and working with AE2S on short term and long-term modeling.

ITEM 7554

Karst presented the report on Administration and Financial Statements, Purchasing, Accounting and Facilities, Projects completed this month: William Neale & Co. completed the audit of our 2020 financials. Projects in Progress: Water service line to operation building is broke and out of service. It is a 1964 Cast Iron that is leaking. We plan on tying it into our new system. Customer Service, Projects Completed this Month: 12,866 payments collected for a total of \$4,615,565 total of 55,041 services billed for a total of \$3,914,279. Human Resources/Risk Management: Prepared supplemental paperwork for annual property and liability insurance renewal, Received final work comp premium for 2020 - approximately 11% decrease from 2019 due to decreased claims in 2020, Retirement of Brad Lueders Water Plant Foreman, effective 8/20/2021. Brad has 6 years of service with the Watertown Municipal Utilities, New hire Alison Kranz, warehouse, effective 6/14/2021. She also attended the SD Municipal League HR School in Pierre. IT: Working on Cybersecurity updates with normal monthly IT maintenance and troubleshooting.

Statements of Revenue and Expenses and Capital Additions were presented to the Board for review. Year to date net income is \$498,513 under budget for the five months ending May 31^{st} , 2021. Total Capital Additions are \$1,075,591 under budget for the five months ending May 31^{st} , 2021.
